- Applicant who parks their container shall undertake and deemed to indemnify and keep Management Corporation fully indemnified against all actions, claims, demands, losses, etc that may be made against the Management Corporation by any person or persons arising out of use of the facility and surrounding areas.
- The Management reserves the right to forfeit in part or in full, the deposit in the event of any damage, claim, loss, etc or for parking beyond the application period or any breach of the terms and conditions stated herein.
