- The Management Office will issue an invoice to the Container Parking Unit based on application and payment made.
- The charges shall apply to ALL weekends, Sundays and Public Holiday.
- Those units who **failed to make application and payment for the container charges one (1) working day before their scheduled entry may be rejected to enter Ubi Tech Park.**
- Applicant who park their container shall undertake and deem to indemnify and keep Management Corporation fully indemnified against all actions, claims, demands, losses, etc that may be made against the Management Corporation by any person or persons arising out of use of the facility and surrounding areas.
- The Management reserves the right to forfeit in part or in full, the said deposit in the event of any damages, claims, losses, etc or parking beyond the application period or breach of the terms and conditions stated herein. Any costs incurred by the Management Corporation in excess of \$100.00 to rectify the irregularities shall be recovered as a debt from the applicant concerned.
